Dual Enrollment Updates - Updated 4/13/2020

Greetings DHHS students and families, we hope this letter finds you well. This letter includes Dual Enrollment updates for the 2020-2021 school year (starting Summer 2020) due to House Bill 444 as well as current updates due to COVID-19. Please check the <u>counseling website</u> for updates as well as the <u>GSFC Dual</u> Enrollment Site.

Please note, we are aware that students might not have testing completed by the April 15th deadline. Our goal is for students to have their college application and online funding application completed by April 15th.

To review changes to Dual Enrollment for the 2020-2021 school year, please review the state released Dual Enrollment FAQ's.

Key points include:

- Changes to allotted credit hours per student the state will fund (30 credit hours max)
- Changes to approved course work
- Grade level in which students can begin taking dual enrollment coursework
- Instructions on how to complete the new online dual enrollment funding application and online student participation agreement (SPA)
 - Counselors do not have access to complete their portion of the online application yet. Further
 guidance will be released in May. Once students and parents have completed the dual
 enrollment agreement, you will see "pending school approval." This means you have
 completed what is necessary at this time.
 - Students will virtually meet with their counselor in May to approve fall classes. Check back to
 the counseling website for updates. In the meantime, students can review the <u>approved</u>
 course list to determine what courses they would like to take.

If you are taking summer 2020 classes, please email your counselor and let her know so classes can be discussed.



How to Apply

Students should complete their college application and online dual enrollment application by April 15th. We are aware that testing might take place after the deadline due to COVID-19. If you are having difficulty completing the application by the deadline, please <u>email your counselor</u>.

Items to complete by April 15th:

- 1. College application (including transcript and test scores if applicable)
- 2. Dual enrollment online funding application and student parent agreement (SPA)
- 3. If taking summer courses email your counselor and let her know so classes can be discussed

Step 1: College Application

The college dual enrollment application varies by college. To view all participating colleges, click here.

If the college requires an ACT or SAT score and the student has not already tested, students will need to wait until testing resumes in June. This may delay the student's starting semester to the spring.

Step 2: Dual Enrollment Online Funding Application and Student Participation Agreement (SPA)

Students must complete the online dual enrollment funding application once per year.

To complete, create an account on www.gafutures.org. Make sure your name, DOB, address, high school, and social security number are correct. Students without a SSN will be provided a GA Futures ID once completing their account.

Once the profile is created, <u>complete the 20-21 Funding Application and Student Participation Agreement</u> (SPA).

Note: Counselors will not be able to complete the school portion until May. Once you see "pending school approval," you have completed the required funding application and parent agreement.



GPTC, GSU Perimeter, and GSU Downtown application information

For testing requirements – Georgia Piedmont Technical and Georgia State will accept the Accuplacer. The schools are working on providing this test to you from your home. For summer and fall 2020, Georgia State will consider students with a 3.0 core GPA (calculated by GSU) without test scores. Read the <u>letter from GSU</u> to learn more. GPTC will also consider <u>alternate admission measures</u> for some students.

 - To send via GA Futures, a social security number must be on file
- 4. GPA or Test Score requirement GPTC Testing Requirements
 - For summer and fall 2020, GPTC will consider HS GPA's for admission. If you have the below GPA, testing is not required.
 - 2.5 GPA+ for degree level academic courses (English, Math, Science, etc.)
 - 2.0 GPA+ for technical level courses
 - Students that do not meet the GPA requirement can take the Accuplacer test at home
- 5. If you are taking summer courses, email your counselor to discuss course options. Fall courses will be discussed starting in May.

 - If you have not yet tested, sign up for the next available date (if applying for spring 2020 or later. Summer and Fall 2020 test score are not required).
